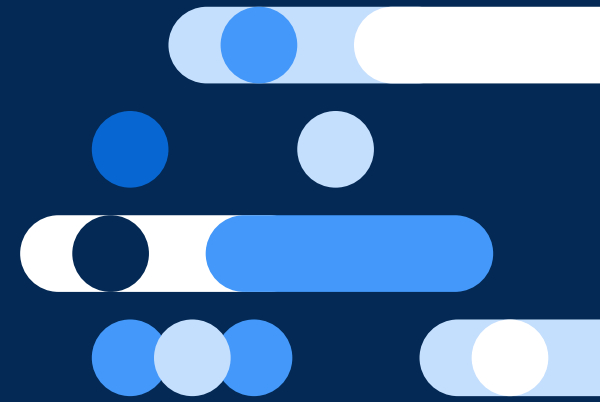




# Employee Benefits and Programs
